

Please read and return the agreement via e-mail. along with a list of your merchandise. This is a juried festival. If you are approved, you will receive an email with instructions on rendering payment. Payment must be received for us to guarantee you a space for vending. There are a limited number of vending spaces, if you delay payment, you may lose your space. Please understand that the completion of this form does not guarantee you a vending space. Merchant Coordinator will assign booth spaces as soon as vending fees have cleared, except in the case of medical necessities. Please notify the Merchant Coordinator if you have special needs due to medical disabilities or have a preference to where your booth will be located when you return this contract.

Your space is not guaranteed until you pay your fees. Fees are \$20.00 general vendors, \$15.00 Sanctuary members, \$10.00 Non-Profits. This price includes a 10x10 space with a 3' clearance between each booth, plus merchants personal area behind their vending booth. The price will increase of \$5.00 on November 24<sup>th</sup>

### Yuletide Bazaar Merchant Contract

I wish to participate as a Merchant at the Yuletide Bazaar. I understand that the fees I have paid provide for a 10x10 space with a 3' clearance between each booth, plus merchants personal area behind their vending booth. I agree to the following stipulations as a Merchant at the Yuletide Bazaar:

and any Misfit Sanctuary agent acting within the scope of his/her duties for any injuries that may occur to my person, my merchandise, or my property. I understand that Misfit Sanctuary Inc. makes no representations or claims as to the condition or safety of the land, structures or surroundings of Belmont National Guard Armory whether or not owned, leased, operated or maintained by Misfit Sanctuary Inc. I understand that Misfit Sanctuary Inc. does not provide any insurance coverage for my merchandise or personal property. I understand that I am responsible for my safety, my own health care needs and the protection of my merchandise and my personal property.

To arrive no earlier than 9:00A.M. on the day of the festival, and not before. I understand that if I arrive before the designated time, I will be turned away at the gate and will have to wait. I understand that my merchandise must be set up by 10:00A.M.

To clear the site by 5:00 P.M.. I understand that this means that all of my merchandise, tents and personal property. I understand that breakdown must begin no earlier or later than 4 P.M.

I understand that if I cancel my booth at the festival less than 30 days before the date of the festival, no refunds will be given.

I hold blameless the Misfit Sanctuary for any merchandise or property that is lost, stolen or damaged. I further understand that any loss of revenue due to my taking checks or credit cards that prove to be invalid I will not be compensated by Misfit Sanctuary or the agents thereof.

To be responsible for my own booth setup, tear down, booth needs (chairs & tables ext.....) and clean up of booth site.

To take away my trash myself.

To keep my vending area clear and free of debris as possible.

To only sell the items that have been approved in advance by the Merchant Coordinator. I understand that if I display any items not approved, I will be asked to remove those items and put them out of sight.

To comply with all State, County and Local ordinances and regulations, I will refrain from selling alcohol and illegal substances. I will comply with the rules for regular attendees as well as Merchant rules.

I agree to leave my animals, except for service animals, at home.

I agree to donate one item for a raffle.

I agree that if I do not abide by these requirements, I may be ejected from site with no refund and I may not be allowed to Merchant at Yuletide Bazaar in the future.

In exchange, Misfit Sanctuary agrees to the following stipulations;

The Merchant Coordinator or his/her designee will be available for merchants from the time of arrival to the time of departure.

Security will be provided during festival.

I understand that when I have paid my fees, submitted list of merchandise, been approved, the signing of this contract, with an electronic signature, with Misfit Sanctuary shall be binding on myself, successors in interest, or any person or persons who would attempt to sue on my behalf. I understand that filling out this form does not guarantee a space for me.
